

VANCITY UNINTERRUPTED VIP CONTEST (the "Contest") Official Rules

Rules

The UNINTERRUPTED VIP contest ("**Contest**") is being offered by Vancouver City Savings Credit Union ("**Vancity**") in accordance with these Official Rules (the "**Rules**"). No purchase necessary to enter or win. Entrants do not need to be member of Vancity. Purchase will not increase your chances of winning.

Eligibility

The Contest is open to residents of British Columbia and, in the case of individuals, those who are 19-years of age or older and who are not directors, officers or employees of Vancity or of any of its affiliates, or members of the immediate family or household of any such person. Winner must be able to be in Vancouver August 11, 2017 to attend the VIP event.

How to Enter

You must have a Facebook or Twitter or Instagram account to enter the Contest. If you do not, visit www.facebook.com or www.twitter.com or www.instagram.com to register in accordance with the respective enrolment instructions for a free account. Entrants must be the authorized holder of the Facebook or Twitter or Instagram account and may be required to show proof. Anyone found using multiple Facebook or Twitter or Instagram accounts to enter the Contest will be disqualified. If you use an automated system or program to enter or otherwise disrupt the Contest, then you may be disqualified.

To enter, you must:

Limit one (1) entry per person and per Facebook or Twitter or Instagram account during the Contest Period.

To be eligible, your entry must:

- Be publicly shared;
- Be shared between 12:00AM July 31 to August 7 at 11:59PM PT, as determined by Vancity's server machines;
- Not be deleted;

- Comply with the respective social media platform's terms of service, available at www.facebook.com and www.twitter.com and www.instagram.com respectively;
- be in keeping with Vancity's public goodwill and image and may not be offensive, inappropriate or indecent, nor can it defame or invade upon the publicity rights or privacy of any person or otherwise infringe upon any person or entity's personal or proprietary rights, as determined by Vancity in its sole discretion. Posts containing any profanity or lewd references will be disqualified at the sole discretion and judgment of Vancity. Without limiting the generality of the foregoing, entries will be disqualified if they include any of the following: Crude, vulgar or offensive language and/or symbols; Derogatory characterizations of any ethnic, racial, sexual or religious groups; Content that endorses, condones or discusses any illegal, inappropriate or risky activity, behaviour or conduct; Personal information of individuals, including without limitation, names and addresses (physical or e-mail); Conduct or other activities in violation of these Rules; Commercial messages, comparisons or solicitations for products or services; Any identifiable third party products and/or trade-marks; URLs or links to any websites; and any other content that is or could be considered inappropriate, unsuitable or offensive, all as determined by Vancity and/or the Contest judges in their sole discretion.

By submitting an entry, each entrant acknowledges that he or she has read and understands and agrees that he or she shall be bound by these Rules. The entrant acknowledges that his/her post may be posted or linked to or used in any media by Vancity in its sole discretion and agrees that Vancity can use his/her Video for promotional or marketing purposes, without any attribution to you. Further, you consent to Vancity contacting you in accordance with these Rules and you agree not to challenge or claim against Vancity in relation to the Contest.

The Contest is in no way sponsored, endorsed or administered by, or associated with, Facebook or Twitter or Instagram. Facebook and Twitter and Instagram are completely released of all liability by each participant in the Contest. You understand that you are providing your information to Vancity and not to the social media platform. Any personal information you provide will be used for the administration of the Contest and in accordance with Vancity's privacy policy (see below). Any questions, or complaints regarding the Contest should be directed to Vancity and not to Facebook or Twitter or Instagram.

Prizes and Chance of Winning

There are eight (84) sets of four tickets (thirty-two tickets in total) available to be won in four contests to be held from June 19 to September 8. Two sets of four tickets will be available for each VIP night on Friday June 30 2017, Friday July 21 2017, Friday August 11 2017, and Friday September 8 2017.

Prize Draw Selection Criteria

The contests will be run on Facebook, Twitter, and Instagram. Contests will be launched 1 week in advance of the event, and the winner will be drawn a week prior to the event. The current contest to run will be during July 31 – August 8. The remaining contest dates are subject to iteration.

The selected entrant will be contacted as follows:

- The selected winners will be contacted by direct message on Twitter or Instagram or on Facebook in a reply to the winner(s) comment with a request for a direct message the day of the draw date, with a request for their full name, email address and phone number.
- The selected winner on Instagram will be contacted by direct message on Instagram the day of the draw date, with a request that they contact Vancity directly via email at socialmedia@vancity.com.

Selected entrant will then be required to send a reply, within 24 hours, to the address provided in Vancity's communication referred to above, to provide their name and full contact information and make arrangements with Vancity for the selected entrant to take all steps required by these rules before being declared a winner. Failure to respond within three days of notification, return of email notification as undeliverable, or failure to comply with these Rules, will result in disqualification.

A selected entrant is subject to verification by Vancity, including proof of identity and eligibility. To be declared a winner, the selected entrant must: (a) correctly answer a time-limited, mathematical skill-testing question, and (b) sign and return, without further compensation, Vancity's Declaration and Release form, which confirms the entrant's compliance with these Rules, acceptance of the Prize as offered, and consent to the use of the entrant's name, city, photograph or any other likeness and/or statement in any publicity carried out by Vancity relating to this Contest. If a selected entrant cannot be reached, does not respond within three days of being left notice of selection, or is unwilling or unable to comply with these Rules, then that entrant may be disqualified and another entrant may be selected at random, at Vancity's sole discretion. Further, a signed copy of Vancity's Declaration and Release must be returned to Vancity, to the address provided on the Declaration and Release, within 7 days of receipt by a selected entrant, or the selected entrant may be disqualified and another entrant may be selected at random, at Vancity's sole discretion.

Release and Indemnification

Each entrant agrees to indemnify, release and hold harmless Vancity, its affiliates and each of their respective directors, officers and employees from any and all liability for any loss, harm, damages, cost or expense arising out of or resulting from, in whole or in part, directly or indirectly, from the entrant's participation in the Contest, participation in any Contest related activity or the acceptance, use or misuse of any Prize awarded in the Contest, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom.

General Terms

All entries become the property of Vancity and will not be returned. No communication with entrants will be entered into except with the selected entrants. Vancity will not be responsible for (i) any incorrect or incomplete submission of entry information by any entrant, (ii) any technical malfunctions, inability to access any online service or website, (iii) any other error or malfunction that could affect your ability to enter the Contest,

(iv) late, lost, stolen, or misdirected entries, (v) any injury or damage to your computer or mobile device resulting from participating in the Contest, or (vi) any data rates that may be charged from your wireless service provider.
